Mike and Ruth,

Since the source of the ASC's concern rested on the Richard Winkler's Engineer's Report, I decided to contact him directly and ask him the question that the ASC had. His report stated that the length of the system should be 100 feet. The graphic that he supplied showed the French drains coming off the left side and right side of the house going toward the back. I asked him if the positions of the French drains could be altered as long as the total length remained the same. He told me that the graphic was merely a suggestion, and that the requirement was for the 100 feet of drainage. Once that was stated, the issue was resolved.

Therefore, the ASC has no concerns with your drainage proposal. You may go ahead with the landscape plan as submitted.
